## Background

Incoterms® are globally recognized, standardized rules on the allocation of obligations, costs and risks in the international trade of goods. They were first codified by the International Chamber of Commerce (ICC) in 1936 and have been updated periodically to reflect the evolution of international trade. The Incoterms® 2020 have been in force since 1.1.2020 and bring numerous innovations that simplify their use and increase their comprehensibility.

Drafting international contracts is always challenging. There are numerous barriers to overcome, such as different languages, domestic trade customs and legal requirements. Incoterms® simplify this process through internationally recognized definitions and rules on the obligations for buyers and sellers regarding transport organization, loading, unloading, costs, transfer of risk, insurance, and customs clearance.
