Background & Objective

Decision-makers in financial institutions recognise that a potential gap exists between current manual document examination activities under Documentary Credits, and evolving digitalisation and automation in other areas of trade finance.

Accordingly, improved understanding is required in terms of what can be done with the new technology. Recent developments in Artificial Intelligence ("AI"), Machine Learning ("ML") and smart Optical Character Recognition ("OCR") are increasingly becoming driving forces behind automation in trade finance.

During that time, he established an institutional partnership between SWIFT and the Inter-national Chamber of Commerce (ICC) and created the first digital trade settlement instrument. André is a Board Member of the International Trade and Forfaiting Association (ITFA Fintech Committee which regroups 41 technology providers.

Dave Meynell is the founder of TradeLC Advisory, an advisory and consultancy service, and the co-owner of www.tradefinance.training, an online training platform for all aspects of trade finance. He previously worked for Deutsche Bank for over 30 years in a number of international locations, culminating as Global Head Trade Product Management for Financial Institutions. David is Senior Technical Advisor for the ICC Banking Commission and former Chief Examiner for the Certificate in International Trade Finance (CITF®).

Michael Vrontamitis is currently advising several companies in an independent capacity and is a member of the World Trade Board. Michael's 25-year career with Standard Chartered spanned both wholesale and retail clients as well as investor relations and he worked in Hong Kong, London and Singapore. He previously held the position of global head of trade finance product and was most recently responsible for Standard Chartered's trade finance business with European and American headquartered companies as well as the business across sales, product, service and implementation in Europe and the Americas.
