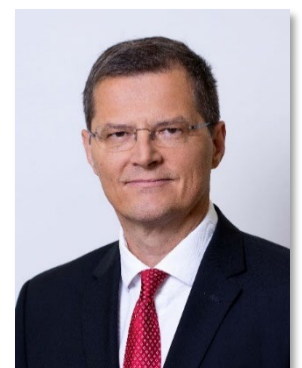

Background

Product liability risk in the US is a business challenge. Again and again we hear about spectacular lawsuits due to defective products, but many companies are not adequately prepared for product liability cases. The aim of this seminar is to familiarize you with product liability law in the US and to explain how best to reduce product liability risk. One key concept is prevention through risk management.

Did you know that

- ▶ you run the full risk of being sued under US product liability law when delivering a machine to the US?
- ▶ thousands of product liability cases are brought before courts in the US year after year?
- ▶ in the event of a product liability lawsuit against your company in the US, a jury decides on the amount of the claims, which are often more than 100 times higher than Austrian claims for damages in similar cases?
- ▶ you have to pay your own legal fees and litigation costs in the US, even if you win ("American Rule")?
- ▶ operating instructions and warnings should be checked critically from a legal point of view and translated well, because inadequate warnings can lead to high product liability claims in the US?
- ▶ correctly formulated contractual limitations of liability and indemnities might offer protection against high payments in the USA?
